



**Price/Earnings:** The trailing price/earnings ratio measures value by dividing a stock's most recent price by the previous year's earnings per share. **EPS Growth:** The forecast growth rate of earnings per share. The price/book (P/B) ratio measures a company's stock price compared with its book value. The ratio is calculated by taking the market price per share of an investment and dividing it by the book value per share. **Price/Cashflow:** The price/cash flow ratio calculates value by dividing a stock's current price by the company's free cash flow over the trailing 12 months. **Long Term Earnings Growth (%)**: The long-term projected earnings growth rate for a stock is the average of the available third-party analysts estimates for three- to five-year EPS growth. **PEG Ratio:** is a stock valuation metric that relates a company's stock price to its expected earnings per share growth rate. P/E divided by expected growth rate. **Cashflow:** Cashflow from operations. Comes from the statement of cashflow. **NAV:** Net Asset Value (NAV) represents the per-share market value of a fund—such as a mutual fund or ETF—calculated by subtracting total liabilities from total assets and dividing by outstanding shares. Updated daily, it helps investors determine the fair value of their holdings. **Market Price:** Market price is the price of an asset that a willing buyer pays to acquire the asset from a willing seller, when a buyer and seller are independent.

**Growth Investing Risk.** Growth stocks can be volatile for several reasons. Since those companies usually invest a high portion of earnings in their businesses, they may lack the dividends of value stocks that can cushion stock prices in a falling market.

**The Morningstar Rating™ ("star rating")** is calculated for funds with at least a three-year history. Exchange-traded and open-end mutual funds are combined into a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of funds in each fund category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating™ is a weighted average of the performance figures associated with a fund's 3-, 5-, and 10-year (if applicable) Morningstar Rating™ metrics. Morningstar rankings are based on a fund's average annual total return relative to all funds in the same Morningstar category. Fund performance used within the rankings, reflects certain fee waivers, without which, returns and Morningstar rankings would have been lower. The highest (or most favorable) percentile rank is 1 and the lowest (or least favorable) percentile rank is 100.
